The Park Model RV's will be designed and constructed to meet applicable building codes and regulations. The PMRV's shall be built off site on a single chassis mounted on wheels and delivered to the site completed.

Proposal Requirements:

Interested parties must submit a detailed proposal outlining their approach to the project, including: a) Design and construction plans for the park model homes. b) Specifications for materials, amenities, and energy efficiency features. c) Pricing information, including itemized breakdown of costs. d) Proposed timeline for construction, delivery, and placement.

Design:

The Design of the Park Model Tiny home should include the following amenities: Sleeping for at least 6 people, Kitchen/kitchenette with Granite Tops, Full bathroom with Walk-in Shower, 18K/24K Split System Unit for Heating/Cooling, Energy Saving package, LP Smart Siding on Exterior, Standing Seam Metal Roof, 50 Amp Electrical Service with 35' Cord, and Furniture package. The PMRV shall be built off site and delivered to the campground as complete as possible. The PMRV shall comply with ANSI A119.5 and RVIA inspected.

Contractors, developers, or manufacturers with experience in PMRV construction are eligible to submit proposals.

All proposals must comply with local building codes, zoning regulations, and other applicable laws.

Proposals will be evaluated based on factors such as design, quality, pricing, sustainability, and experience. Please include sample photos, renderings, etc.
